#### Medical Access Assistant (MAA)

MPN regulations require that an individual be provided by the MPN to help injured workers with finding available medical provider network physicians of the injured workers' choice and with scheduling provider appointments. The MAA will assist with scheduling an appointment for the first treatment visit in the MPN and an initial appointment with a specialist in an appropriate referred specialty. The MAA can be reached at 1-800-944-0443 from 7 a.m.to 8 p.m. Pacific, Monday through Saturday (except holidays).

#### MPN Contact

MPN regulations require that an individual be available who is responsible for responding to complaints, for answering employees' questions about the MPN and for assisting employees in arranging for an MPN independent medical review pursuant to L.C. section 4616.4. If you would
